In late November 2020, the Trump Administration reportedly decided to request the procurement of a second Virginia-class attack submarinein FY2021. CRS as of December 10, 2020, had not received any documentation from the Administration detailing the exact changes to the Virginia-class program funding linesthat would result from this reported change. Pending the delivery of that information from the administration, this CRS report continues to use the Navy's original FY2021 budgetsubmission in its tables and narrative discussions.
