The results suggest that the frequency with which words are used together mediates the distribution of mixing patterns in each of the examined contexts. The differing impacts of co-occurrence frequency are attributed to the distributional and semantic specifics of the analyzed morphosyntactic configurations. Lexical frequency has been found to be another important determinant in this variation. Other factors include recency, or lexical priming, in discourse in the case of prepositional phrases, and phonological and structural similarities and differences in the inflectional systems of the contact languages in the case of plural marking.
